He is an active angel investor with several investments primarily in Africa-based tech companies.
- Amy Marsh recently retired as Chief Investment Officer (CIO) and Treasurer at the University of Pittsburgh. There, she served as the managing director of the Office of Finance, where she was responsible for managing the assets and liabilities of the University and its endowment. In addition to her newly elected role, Ms. Marsh serves on the boards of several Pennsylvania-based organizations, including the Sewickley Academy, a private day school where she is a Trustee Emeritus and serves on the Endowment, Finance and Audit Committees.
- O Dan Katzir is the President and CEO of Alliance College-Ready Public Schools, a nonprofit public charter school network that serves 13,000 students and 12,000 alumni across 28 public charter schools in Los Angeles, California. Previously, Mr. Katzir was the founding Managing Director of the

Eli and Edythe Broad Foundation, Regional Director of Sylvan Learning Systems, Executive Director for UCLA's School Management Program and Chief Operating Officer for Teach for America.
